The Clerk's office submitted our ballot order for the November 4, 2025, Dexter Washtenaw Intermediate School Millage, which will be a special election. Dexter Township will host both Precinct #1 and Precinct #3D at the Dexter Township Hall location and Precinct #2 at the Dexter Fire Department station #2. The consensus of the Washtenaw Clerk's agreed that we would forgo offering 9-day early voting which would save the school and taxpayers funds. The WISD School will be responsible for the reimbursement of all the municipality's costs to open and run the precincts to host the election that fall in the Washtenaw County Schools District.
